REGULATION

1. Citation and commencement

3. Amendment of Schedule to the Regulations

IN EXERCISE of the powers conferred on the Minister of Investment, Trade and Industry by section 3 of the Control of Goods, Prices and Other Charges Act, the following Regulations are hereby made —

1. These Regulations may be cited as the Control of Goods, Prices and Other Charges (Petroleum Prices) (Amendment) (No. 1) Regulations, 2017, and shall come into force on 4th March, 2017. Citation and commencement

2. The Control of Goods, Prices and Other Charges (Petroleum Prices) Regulations (hereinafter referred to as “the Regulations”) are amended in regulation 3 (a) (i) and (ii) by substituting for the words, “a levy of 80 thebe per litre in respect of the Road Fund”, the words, “a levy of 90 thebe per litre in respect of the Road Fund”. Amendment of Cap. 43:08 (Sub. Leg.)

3. The Regulations are amended by substituting, for the Schedule thereto, the following new Schedule — Amendment of Schedule to the Regulations
