1. Citation and commencement

IN EXERCISE of the powers conferred on the Minister of Investment, Trade and Industry by section 3 of the Control of Goods, Prices and Other Charges Act, the following Regulation are hereby made —

Citation and

1. These Regulations may be cited as the Control of Goods (Aviation Fuel Prices) (Amendment) Regulations, 2017 and shall come into force on 1st July 2017.
