CONTROL OF OIL.

It is hereby notified for general information that, under and by virtue of the powers vested in him by section *one* of the Basutoland Emergency Powers (Defence) Proclamation, 1939 (No. 35 of 1939), section *one* of the Bechuanaland Protectorate Emergency Powers (Defence) Proclamation, 1939 (No. 36 of 1939), and section *one* of the Swaziland Emergency Powers (Defence) Proclamation, 1939 (No. 37 of 1939), respectively, His Excellency the High Commissioner has been pleased to amend the regulations relating to the sale and distribution of lubricating oil in Basutoland, the Bechuanaland Protectorate, and Swaziland published under High Commissioner's Notice No. 135 of 1942, as amended by High Commissioner's Notice No. 167 of 1942, hereinafter referred to as "the said regulations", as follows:—

1. By the deletion of Annexure A to the said regulations and the substitution therefor of the Annexure attached hereto:

2. By the deletion of section 7 of the said regulations and the substitution therefor of the following section:—

"7. ~~Petrol~~ counterfoils and oil coupons shall be valid for the month of issue and seven months thereafter:

Provided that the period shall be eight months in the case of a reseller obtaining supplies from a wholesaler."
