

BECHUANALAND PROTECTORATE.

HIGH COMMISSIONER'S NOTICE

No. 227 OF 1947.

It is hereby notified for general information that under and by virtue of the powers vested in him by section *nine* of the Bechuanaland Protectorate Police Proclamation, 1937 (No. 69 of 1937), His Excellency the High Commissioner has been pleased to amend the Bechuanaland Protectorate Police Regulations, published under High Commissioner's Notice No. 212 of 1937, as follows:—

1. Regulations 2, 4, 8, 10, 11, 16, 20 (a), 21, 22, 27, 31, 35, 38, 39, 40, 41, 43, 44 and 45 are amended by deleting the word "Commandant" and substituting therefor the word "Commissioner".

2. Regulations 12, 14, 20 (b), 23 and 28 are amended by deleting the word "Commandant" and substituting therefor the words "Resident Commissioner".

3. Regulations 11, 16, 18, 21, 25 and 26 are amended by deleting references to "Police Messengers".

4. Regulation 2 is amended by deleting the word "Inspectors" and substituting therefor the word "Superintendents".

5. Regulation 9 is deleted.

6. Regulation 14 is amended by deleting the words "European non-commissioned officers or men" and substituting therefor the words "subordinate officers or police cadets".

7. Regulation 18 is amended by deleting the figure "20" and substituting therefor the figure "18".

8. Regulation 19 is amended by deleting the words "Any commissioned officer or warrant officer" and substituting therefor the words "Any senior officer or senior inspector".

9. Regulation 20 is amended by deleting the words "Warrant Officer" and substituting therefor the words "senior inspector".

10. Regulation 26 is amended—

(i) by deleting the words "Any Commissioned Officer of Police" and substituting therefor the words "Any senior officer";

(ii) by deleting the words "Warrant Officers" and substituting therefor the words "senior inspectors";

(iii) by deleting the words " European Non-commissioned Officers " and substituting therefor the words " subordinate officers other than senior inspectors " ; and

(iv) by deleting the words " European Troopers " and substituting therefor the words " police cadets " .

11. Regulation 27 is amended by deleting the word " Deputy-Commandant " and substituting therefor the word " Commissioner " .

12. Regulation 29 is deleted.

13. Regulation 32 is amended by deleting the words " warrant or non-commissioned officer," and substituting therefor the words " Subordinate officer," .

14. Regulation 36 is amended by deleting the words " non-commissioned officer or man " and substituting therefor the words " member of the Force " .

15. Regulation 44 is amended by deleting the words " officer, warrant officer, non-commissioned officer, or man " and substituting therefor the words " member of the Force " .

16. Regulation 46 is amended by deleting the words " Non-commissioned officers and men " and substituting therefor the words " Members of the Force " .

17. Part IV (Schedule of Offences) of the Regulations is amended by deleting the words " superior officer " in paragraphs 4 and 5 and substituting therefor the words " senior member " .
