

**Legal Notice No. 17 of 1966.**

**THE LOCAL GOVERNMENT (DISTRICT COUNCILS) LAW, 1965  
PREPARATORY COMMISSIONS ORDER, 1966**

In exercise of the powers vested in him by section 59 of the Local Government (District Councils) Law, 1965 (No. 35 of 1965) His Excellency Her Majesty's Commissioner hereby makes the following Order—

**Title.**

1. This Order may be cited as the Preparatory Commissions Order, 1966.

**Establishment of Preparatory Commissions.**

2. There is hereby established a Preparatory Commission in respect of each of the areas specified in the first column of the Schedule consisting of the Chairman and members referred to opposite thereto in the second column of the said Schedule.
