**THE FAUNA CONSERVATION (TRIBAL TERRITORIES CONTROLLED HUNTING AREAS) (AMENDMENT NO. 2) REGULATIONS, 1969**

(Published on 14th March, 1969)

In the exercise of the powers vested in him by section 11 read with section 93 of the Fauna Conservation Proclamation, 1961 (No. 22 of 1961) the Minister of Commerce, Industry and Water Affairs makes the following regulations —

**Citation**

1. These Regulations may be cited as the Fauna Conservation (Tribal Territories Controlled Hunting Areas) (Amendment No. 2) Regulations, 1969.

**Substitution of First Schedule to Statutory Instrument No. 23 of 1968**
