**THE TOWNSHIPS PROCLAMATION (CHAPTER 120)
THE LOCAL GOVERNMENT (DISTRICT COUNCILS) LAW, 1965
THE LOCAL COUNCILS (CONDUCT OF ELECTIONS) (AMENDMENT)
REGULATIONS, 1969**

In the exercise of the powers vested in him by section 2 of the Townships Proclamation (Chapter 120) and section 55 of the Local Government (District Councils) Law, 1965, His Excellency the President hereby makes the following regulations -

Citation

1. These Regulations may be cited as the Local Councils (Conduct of Elections) (Amendment) Regulations, 1969.

Amendment of Regulation 2 in Legal Notice No. 32 of 1966

2. Regulation 2 of the Local Councils (Conduct of Elections) Regulations, 1966 (hereinafter referred to as the principal regulations) is amended -

- (a) by the deletion of the definition of "Minister";
- (b) by the deletion of the definition of "polling district" and the substitution therefor of " "polling district" has the same meaning as is assigned thereto in the Electoral Act, 1968.";
- (c) by the deletion of the definition of "polling station" and the substitution therefor of " "polling station" has the same meaning as is assigned thereto in the Electoral Act, 1968.";
- (d) by the deletion in the definition of "registered" of "Legislative Assembly (Registration of Voters) Regulations, 1964 (as amended)" and the substitution therefor of "Electoral Act, 1968.";
- (e) by the deletion in the definition of "voters registration card" of "Legislative Assembly (Registration of Voters) Regulations, 1964 (as amended)" and the substitution therefor of "Electoral Act, 1968.".

Amendment of Regulation 3 in Legal Notice No. 32 of 1966

3. Regulation 3 of the principal regulations is amended -

- (a) in subregulation (1) by the insertion of "Election" between "Local Government" and "Supervisor";
- (b) in subregulation (3) by the deletion of "Election Officer" and "them" and the substitution for those words of "An election officer" and "him" respectively.

Amendment of Regulation 8 in Legal Notice No. 32 of 1966

4. Regulation 8 of the principal regulations is amended in paragraph (a) of subregulation (2) by the insertion between "or" and "possess" of "does" and by the deletion of "of the persons".

Amendment of Regulation 12 in Legal Notice No. 32 of 1966

5. Regulation 12 of the principal regulations is amended by the deletion of "hereafter" and the substitution therefor of "thereafter".

Amendment of Regulation 15 in Legal Notice No. 32 of 1966

6. Regulation 15 of the principal regulations is amended in the proviso to subregulation (2) by the deletion of "regulation 117 of the Legislative Assembly (Conduct of Elections) Regulations, 1964" and the substitution therefor of "section 149 of the Electoral Act, 1968."

Amendment of Regulation 40 in Legal Notice No. 32 of 1966

7. Regulation 40 of the principal regulations is amended in subregulation (2) by the deletion after "writing" of "on" and the substitution therefor of "of", and by the deletion of "who" and the substitution therefor of "whom".

Amendment of Regulation 41 in Legal Notice No. 32 of 1966

8. Regulation 41 of the principal regulations is amended –

- (a) in subregulation (1) by the deletion of the comma after "proceed";
- (b) in subregulation (4) by the deletion of "(2)" and the substitution therefor of "(3)".

Amendment of Regulation 55 in Legal Notice No. 32 of 1966

9. Regulation 55 of the principal regulations is amended in subregulation (1) by the deletion of the words "in respect of the conduct or management of that election by that candidate or" where they first occur.

Amendment of Regulation 57 in Legal Notice No. 32 of 1966

10. Regulation 57 of the principal regulations is amended in subregulation (3) by the deletion of the comma after "provisions" and the substitution therefor of "of these Regulations".

Amendment of Regulation 63 in Legal Notice No. 32 of 1966

11. Regulation 63 of the principal regulations is amended in subregulation (1) by the deletion after "such evidence" of "on" and the substitution of "of".

Amendment of Form A in Schedule to Legal Notice No. 32 of 1966

12. Form A in the Schedule to the principal regulations is amended –

- (a) by the insertion after "Local Government", wherever those words occur, of "and Lands";
- (b) by the deletion of "Public Seal".

Amendment of Form B in Schedule to Legal Notice No. 32 of 1966

13. Form B in the Schedule to the principal regulations is amended by the insertion in the first paragraph after "Local Government" of "and Lands".

Amendment of Form C in Schedule to Legal Notice No. 32 of 1966

14. Form C in the Schedule to the principal regulations is amended in declaration (b) on the back of the nomination paper by the deletion of "section 7 of the Local Government (District Councils) Law, 1965" and the substitution therefor of "section 63 of the Constitution".

Amendment of Form F in Schedule to Legal Notice No. 32 of 1966

15. Form F in the Schedule to the principal regulations is amended by the deletion of the heading "Bechuanaland Elections".
