ENACTED by the Parliament of Botswana.

1. This Act may be cited as the Appropriation (1971/1972) Act, 1971. Short title

2. The Minister of Finance and Development Planning may issue a warrant for the payment from the Consolidated Fund for the year ending on 31st March, 1972, of the sum of R17,146,936 (seventeen million one hundred and forty-six thousand nine hundred and thirty-six rand). Expenditure

3. The sum authorised by section 2 is appropriated to and shall be applied for the purposes of the heads of expenditure set out in the first and second columns of the First Schedule, in the amounts set opposite thereto in the third column of that Schedule. Appropriation

4. The Minister of Finance and Development Planning may issue a warrant for the payment from the Development Fund for the year ending on the 31st March, 1972, of the sum of R23,548,617 (twenty-three million five hundred and forty-eight thousand six hundred and seventeen rand).

5. The sum authorised by section 4 is appropriated to and shall be applied for the purposes of the heads of expenditure set out in the first and second column of the Second Schedule, in the amounts set opposite thereto in the third column of that Schedule.
