The Consolidated Fund of Botswana is hereby charged with a further sum of R723,926 (seven-hundred and twenty-three thousand, nine-hundred and twenty-six rand) to meet expenditure incurred during the Financial Year ended on the 31st March, 1970, in excess of the amount appropriated for the services for that year, according to the particulars set forth in the First Schedule to this Act.

The Development Fund is hereby charged with a further sum of R638,668 (six-hundred and thirty-eight thousand, six-hundred and sixty-eight rand) to meet expenditure incurred during the Financial Year ended on the 31st March, 1970, in excess of the amount appropriated for development for that year, according to the particulars set forth in the Second Schedule to this Act.
