IN EXERCISE of the powers conferred by section 4 of the Post Office Proclamation, 1961 I, A.T. Whitehead, Acting Director of Posts and Telecommunications, hereby make the following regulations —

### RESTRICTION OF EXTERNAL MONEY ORDER REMITTANCES

In terms of Exchange Control regulations no remittance may exceed R50.00 as that is the maximum amount which may be transferred in any month to countries outside the Republic of South Africa, South West Africa, Lesotho, Swaziland and Botswana.

### INLAND TELEGRAPHIC MONEY ORDERS CHARGES FOR TELEGRAMS OF ADVICE

The charge for the telegram of advice of a telegraphic Money Order drawn on an office in Botswana is 25c irrespective of the number of words therein or the number of orders involved where the remittance exceeds R200. The remitter may, on paying for the additional words required, have a short private communication for the payee, not exceeding twelve words.

Telegrams of advice of orders drawn on offices in Lesotho, Swaziland, Republic of South Africa, South West Africa, Mocambique, Rhodesia, Malawi and Zambia are charged for in accordance with the tariff for plain language telegrams set forth in section 3 – Telegrams. The remitter may, on paying for the additional words required have a short private communication for the payee, not exceeding twelve words.

Telegrams of Advice of telegraphic money orders may be sent as urgent telegrams to offices within Lesotho, Swaziland, Republic of South Africa, South West Africa, Mocambique, Southern Rhodesia, Malawi and Zambia on payment of double the telegraph for an ordinary advice telegram.

If alteration of the names of the payee or remitter should be required, a corrected telegraphic advice will be sent by the issuing Postmaster upon payment by the remitter of a fee of 25c telegraph charge in the case of Botswana. To other countries a telegraph charge on a word basis applies.

### FOREIGN MONEY ORDERS CHARGES FOR TELEGRAMS OF ADVICE

A charge for the telegram of advice at the ordinary or letter telegram rate, as the remitter prefers. The remitter is allowed, on paying for the additional words required, to add to the telegram of advice any short communication for the payee, not exceeding twelve words.

### OTHER CHARGES

#### ADVICES OF PAYMENT

(Inland Money Orders)

(a) .. .. . 5c

(b) If an advice of payment is required by telegraph, the remitter must pay the charge of the telegram of advice, the advice of payment fee 5c plus the cost of the telegraph reply.

The charge for the telegraph reply from an office in Botswana is 25c. From any other office the charge is in accordance with the tariff for plain language telegrams.

**ADVICES OF PAYMENT**

(Foreign Money Orders)

- (a) . . . . . 5c
- (b) If the remitter wishes to request for an advice of payment to be communicated to the office of payment in the telegram of advice, he must pay the cost of the telegram including the words "Advice Payment". The reply in such cases will be sent from the office of payment by post.

**SUMMARY OF MISCELLANEOUS CHARGES**

9. For an acknowledgement of receipt of a registered article by the addressee (regulation 79 (5)). . . . . 5c
10. For compulsory registration (regulation 79 (6)) . . . . . 20c
11. For a parcel posted in a posting box (regulation 81 (2)). . . . . 3c
12. For the stoppage of a parcel during transmission through the post and delivery from the office at which stoppage is effected (regulation 81 (5)) . . . . . 10c
13. Demurrage charges on parcels (regulation 81 (7)) . . . . . First 10 days free of charge. Thereafter 3c per day.

#### INTER-TERRITORIAL TRUNK CALLS

- (1) The charges for inter-territorial trunk calls shall be based on the establishment of border points between Botswana and the country concerned at such points as may be agreed between the two Administrations and shall be the sum of -
  - (a) the charge from the originating exchange to the border point; and
  - (b) the charge from the border point to the called exchange;
- (2) The charge from the border point to the exchange in the other country concerned shall be as specified from time to time by the Administration of that country.
- (3) The charge from an exchange within Botswana to the border point shall be as specified in regulation twelve.
- (4) In calculating the charge any fraction of a cent shall be rounded up to the nearest whole cent.

#### SUPPLEMENTARY TRUNK SERVICE CHARGES

##### FIXED TIME CALLS

Arrangements may be made in advance for trunk communication with a given number to be effected at a specified time and this may be repeated over a period by special arrangement. The transaction is at caller's risk, and if the callee does not respond, the prescribed fee will nevertheless be charged:-

- (a) Internal fixed-time call -
  - (i) single fixed-time call 50 per cent of the charge for a three-minute trunk call.
  - (ii) daily fixed-time call 25 per cent of the charge for a three-minute trunk call.
- (b) Inter-territorial fixed-time call 50 per cent of the charge for a three-minute trunk call.

### PERSONAL CALLS

When making application for a trunk call to a subscriber's telephone the caller may request that a particular person should be called to that telephone, by the subscriber, for the call:-

The charges shall be as follows:-

- (a) Personal charge for a call within Botswana or to Malawi, Mocambique, Southern Rhodesia and Zambia 33 $\frac{1}{3}$  per cent of the charge for a three-minute trunk call.
- (b) Personal charge for a call to Lesotho, South Africa, South West Africa or Swaziland The charge for a three minute trunk call.

### MESSENGER SERVICE

Arrangements may be made for an advice to be sent to any person who can be reached by delivery of a message within a reasonable distance from a telegram office, requesting him to attend at a public call office. The fees for the transmission of such message shall be 50c.
