ENACTED by the Parliament of Botswana.

1. This Act may be cited as the Supplementary Appropriation (1970/1971) (No. 2) Act, 1972. Short title

2. The Consolidated Fund of Botswana is hereby charged with a further sum of R46,258 (forty six thousand two hundred and fifty eight rand) to meet expenditure incurred during the financial year which ended on the 31st March, 1971, in excess of the amount already appropriated for the services for that year according to the particulars set forth in the First Schedule to this Act. The Development Fund is hereby charged with a further sum of R233,009 (two hundred and thirty three thousand and nine rand) to meet expenditure incurred during the financial year which ended on the 31st March, 1971, in excess of the amount already appropriated for development for that year, according to the particulars set forth in the Second Schedule to this Act.
