### **AN ACT TO AUTHORIZE THE PAYMENT OUT OF THE CONSOLIDATED FUND AND THE DEVELOPMENT FUND OF SUMS OF MONEY FOR THE YEAR ENDING ON THE 31ST MARCH, 1974.**

*Date of Assent* : 29.3.73

*Date of Commencement* : 30.3.73

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the Appropriation (1973/74) Act, 1973. Short title

2. The Minister of Finance and Development Planning may issue a warrant for the payment from the Consolidated Fund for the year ending on the 31st March, 1974, of the sum of R34 447 610 (thirty-four million four hundred and forty-seven thousand six hundred and ten rand).

**Appropriation**      **3.** The sum authorized by section 2 is appropriated to and shall be applied for the purposes of the heads of expenditure set out in the first and second columns of the First Schedule, in the amounts set opposite thereto in the third column of that Schedule.

**Expenditure from Development Fund**      **4.** The Minister of Finance and Development Planning may issue a warrant for the payment from the Development Fund for the year ending on the 31st March, 1974, of the sum of R55 432 585 (fifty-five million four hundred and thirty-two thousand five hundred and eighty-five rand).

**Appropriation**      **5.** The sum authorized by section 4 is appropriated to and shall be applied for the purposes of meeting the total amount of expenditure necessary for development projects during the financial year ending on the 31st March, 1974.
