1. This Act may be cited as the Supplementary Appropriation (1971/1972) Act, 1973. Short title

2. The Consolidated Fund is hereby charged with a further sum of R1 928 595 (one million nine hundred and twenty-eight thousand five hundred and ninety-five rand) to meet expenditure incurred during the financial year which ended on 31st March, 1972, in excess of the amount already appropriated for the services for that year, according to the particulars set forth in the First Schedule to this Act. The Development Fund is hereby charged with a further sum of R16 169 682 (sixteen million one hundred and sixty-nine thousand six hundred and eighty-two rand) to meet expenditure incurred during the financial year ended on 31st March, 1972, in excess of the amount already appropriated for development for that year, according to the particulars set forth in the Second Schedule to this Act.
