**THE COMMISSIONERS OF OATHS (AMENDMENT OF SCHEDULE)  
NOTICE, 1972**

*(Published on the 5th January, 1973)*

In the exercise of the powers vested in him by section 2 of the Commissioners of Oaths Proclamation, the Minister of Health, Labour and Home Affairs hereby gives notice as follows –

1. This Notice may be cited as the Commissioners of Oaths (Amendment of Schedule) Notice, 1972. Citation

2. The Commissioners of Oaths Proclamation (Chapter 50) is amended by the deletion of Part II of the Schedule thereto and the substitution of – Replacement of Part II of Schedule of Cap. 50
