(Published on 31st December, 1974)

IN EXERCISE of the powers conferred by section 5 (2) of the Revision of the Laws Act, 1973. His Excellency the President hereby makes the following Order --

1. This Order may be cited as the Law Revision Order, 1974. Citation
2. As from the date of commencement of this Order the pages specified in column 3 of the Schedule of the written laws specified in columns 1 and 2 of the said Schedule are authorized for inclusion in and shall form part of the Laws of Botswana. Authority for inclusion of pages in Laws of Botswana
3. The written laws referred to in paragraph 2 shall, unless otherwise provided, represent the respective laws in force in Botswana on the 1st January, 1973. Effective date of laws
