**LAW REVISION ORDER, 1975**

(Published on the 31st December, 1975)

IN EXERCISE of the powers conferred by section 5 (2) of the Revision of the Laws Act, His Excellency the President hereby makes the following Order —

1. This Order may be cited as the Law Revision Order, 1975. Citation
2. As and from the commencement of this Order the pages specified in column 3 of the First Schedule of the written laws specified in columns 1 and 2 of the said Schedule are authorized for inclusion in and shall form part of the Laws of Botswana. Authority for inclusion of pages in Laws of Botswana
3. As and from the commencement of this Order —
  - (a) the pages specified in the Second Schedule are authorized to be removed from, and Authority for removal and inclusion of certain pages
  - (b) the pages specified in the Third Schedule are authorized to be included in, Pagesthe Laws of Botswana.
4. The written laws referred to in paragraphs 2 and 3 (b) shall, unless otherwise specified, represent the respective laws in force in Botswana on 1st January, 1974. Effective date of laws
