TRADING (PRESCRIBED FORMS) (AMENDMENT) REGULATIONS, 1975

(Published on the 24th December, 1975)

IN EXERCISE of the powers conferred by section 47 of the Trading Act, 1966, the Minister of Commerce and Industry hereby makes the following Regulations —

1. These Regulations may be cited as the Trading (Prescribed Forms) (Amendment) Regulations, 1975. Citation
