LAW REVISION ORDER, 1976

(Published on 26th November, 1976)

IN EXERCISE of the powers conferred by section 5 (2) of the Revision of the Laws Act upon His Excellency the President, and in pursuance of directions in writing issued under section 36 (1) of the Constitution, His Honour the Vice-President hereby make the following Order –

| Citation | 1. This Order may be cited as the Law Revision Order, 1976. |
| Authority for inclusion of pages in Laws of Botswana | 2. As and from the commencement of this Order the pages specified in column 3 of the First Schedule of the written laws specified in columns 1 and 2 of the said Schedule are authorized for inclusion in and shall form part of the Laws of Botswana. |
| Authority for removal and inclusion of certain pages | 3. As and from the commencement of this Order – (a) the pages specified in the Second Schedule are authorized to be removed from land, (b) the pages specified in the Third Schedule are authorized to be included in, the Laws of Botswana. |
| Effective date of laws | 4. The written laws referred to in paragraphs 2 and 3 (b) shall represent the respective laws in force in Botswana on 1st January, 1976. |
