| Authority for inclusion of pages in Laws of Botswana | 2. As and from 31st December, 1976, the pages specified in the third column of the First Schedule of the written laws specified in the first and second columns of the said Schedule are authorized for inclusion in and shall form part of the Laws of Botswana. |
| Authority for removal and inclusion of certain pages | 3. As and from 31st December, 1976, —
(a) the pages specified in the third column of the Second Schedule of the written laws specified in the first and second columns of the said Schedule are authorized to be removed from, and
(b) the pages specified in the third column of the Third Schedule of the written laws specified in the first and second columns of the said Schedule are authorized to be included in, the Laws of Botswana. |
| Effective date of laws | 4. The written laws referred to in paragraphs 2 and 3 (b) represent the respective laws in force in Botswana on 1st January, 1977. |
| Revocation of S.I. 140 of 1977 | 5. Law Revision Order, 1977, is hereby revoked. |
