An Act to amend the National Assembly (Salaries and Allowances) Act, 1980

Date of Assent: 16.9.81.

Date of Commencement: 1.4.81.

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the National Assembly (Salaries and Allowances) (Amendment) Act, 1981, and shall be deemed to have come into operation on 1st April, 1981. Short title and commencement
2. Section 3 of the National Assembly (Salaries and Allowances) Act, 1980, (hereinafter referred to as "the principal Act"), is amended by substituting for subsection (1) thereof the following new subsection — Amendment of section 3 of Act 21 of 1980

“(1) The Speaker and Deputy Speaker of the National Assembly shall each be paid, from moneys appropriated by law for such purpose, the appropriate salary payable in terms of section 4.”.
3. Section 4 of the principal Act is amended by renumbering the section as subsection (1) thereof and adding thereto the following new subsection — Amendment of section 4 of principal Act

“(2) The President may, by order published in the Gazette, amend paragraph 4 of the Schedule in order to vary the allowances therein prescribed.”.
4. The Schedule to the principal Act is amended — Amendment of Schedule to principal Act
 - (a) in paragraph 1 thereof, by substituting for subparagraph (1) the following new subparagraph —

“(1) Each Member shall receive a salary calculated, in the case of —

 - (a) the President, at the rate of P26 004 per annum;
 - (b) the Vice-President, at the rate of P18 000 per annum;
 - (c) any other Minister, not being an Assistant Minister, at the rate of P14 040 per annum;

- (d) an Assistant Minister, at the rate of P12 600 per annum;
- (e) the Speaker, at the rate of P9 180 per annum;
- (f) the Leader of the Opposition, at the rate of P9 180 per annum;
- (g) any other Member, including the Deputy Speaker, at the rate of P8 244 per annum.”;
- (b) in paragraph 5 thereof, by substituting for the words “P6”, which appear therein, the words “P10”;
- (c) in paragraph 7 thereof, by substituting for the words “P240”, which appear therein, the words “P480”; and
- (d) by deleting paragraph 10.
