Schedule No. 1 to the Act set out in the Schedule to the amendment of Schedules (No.19) Notice, 1981 is hereby amended by substituting for the words "25% or .15UA each" which appear in column III opposite item 83.07.25 sub item 20 in column 1, the words "10% or .067UA each". |

(a) in column II by substituting for the words "25% or 10.50 UA kg less 75%" which appear opposite item 53.11 in column I the words "25% or 10.50 UA per kg less 75%".
(b) in column I —
(i) by substituting for the words "84.64" which appear in line 3, opposite item 84.62 in column I the words "84.62".
(ii) by inserting the word "not" which appears opposite item 84.62.06.10 in column I, after the word "but" and before the word "exceeding".
(iii) by substituting for the word "other" which appears in line 4 opposite item 84.62.47 in the same column the word "outer". |

- (iv) by deleting the words "or more" which appear in lines 1/2 opposite item 84.62.47.15 in the same column
4. Schedule No. 1 to the Act set out in the Schedule to the Amendment of Schedules (No. 23) Notice, 1981 is hereby amended –
- (a) in column II by substituting for the word "meta" which appears in line 5 the words "meta –";
 - (b) in column I by substituting for the word "20.16" the words "29.16";
 - (c) in column II by substituting for the word "packing" which appears in line 4 opposite item 31.05.10 in column I the word "packings";
 - (d) in column III by substituting for the words "225%", which appear opposite item 51.04, subitem .30 in column I, the words "25%";
 - (e) in column II by deleting the word "with", which appears in line 1 opposite item 83.15 subitem .10 in column I; and
 - (f) in column II by inserting the word "as" immediately after the word "times", which appears in line 1 opposite item 460.06 sub item 31.03 in the same column.
5. Schedule No. 1 to the Act, set out in Schedule to the Amendment of Schedules (No. 24) Notice, 1981 is hereby amended by substituting for the word "acetate", which appears opposite item 29.14 sub item .45 in the first column the word "acetates".
6. Schedule No. 3 to the Act set out in the Schedule to the Amendment of Schedules (No. 24) Notice, 1981 is hereby amended by substituting for the word "forms" in line II, which appears in column II the word "forks".
7. Schedule No. 1 to the Act, set out in the Schedule to the Amendment of Schedules (No. 25) Notice, 1981 is hereby amended by –
- (a) in column I by substituting for the word "cosmetci", which appears in line 1/2 opposite item 33.06, in the same column the word "cosmetic";
 - (b) in column I by substituting for the word "solutions", which appear in line 6 opposite item 33.06, in the same column the word "solutions".
8. Schedule No. 4 to the Act is hereby amended by –
- (a) in column II by deleting the words "74.07 tubes and pipes, of copper, in such quantities and at such times as the Permanent Secretary, Ministry of Commerce and Industry may allow by specific permit" which appear opposite item 460.15 in the first column;
 - (b) in column III by deleting the words "full duty" which appear opposite item 460.15 subitem 74.07 in the second column.
