IN EXERCISE of the powers conferred on the Minister of Commerce and Industry by section 3 of the Control of Goods, Prices and Other Charges Act, the following Regulations are hereby made —

| Citation  | 1. These Regulations may be cited as the Control of Goods, Prices and Other Charges (Import and Export of Certain Agricultural Products) Regulations, 1981.   |
| Restriction on importation of certain agricultural products | 2. No person shall import any agricultural product specified in the First Schedule except under and in accordance with a written permit issued under this regulation by the Minister for the time being responsible for agriculture or by an officer authorized by that Minister in that behalf:<br>Provided that this regulation shall not apply to the importation of —<br>(i) green maize, commonly known as mealies;<br>(ii) seed intended for planting, being a consignment or part of a consignment clearly marked as seed; or<br>(iii) any agricultural products specified in the First Schedule if —<br>(a) the aggregate weight of the products imported in any one period of 12 months does not exceed 1 400 kg; and<br>(b) the products are for consumption as food by the person importing them or by his immediate family or have been received by him in lieu of wages. |
| Restriction on exportation of certain agricultural products | 3. No person shall export any agricultural product specified in the Second Schedule except under and in accordance with a written permit issued under this regulation by the Minister for the time being responsible for agriculture or by an officer authorized by that Minister in that behalf.   |
| Revocation of S.I. 56 of 1977                               | 4. The Control of Goods (Import and Export of Agricultural Products) Regulations, 1977, are hereby revoked.   |
