REGULATION

1. Citation and commencement

IN EXERCISE of the powers conferred on the Minister of Works and Communications by section 56 of the Post Office Act, 1980, the following Regulations are hereby made—

1. These Regulations may be cited as the Post Office (Postage and Miscellaneous Charges) (Amendment) Regulations, 1981, and shall be deemed to have come into operation on 1st July, 1981.
