1. Citation and commencement

IN EXERCISE of the powers conferred on the Minister of Local Government and Lands by section 3 (6) of the Tribal Land Act, the following Order is hereby made —

1. This Order may be cited as the Tribal Land (Amendment of Schedule) Order, 1981, and shall be deemed to have come into operation on 1st October, 1981.

- (a) by substitution for entry (d) in relation to the Ngwato Land Board the following new entry —
“(d) six members appointed by the Minister.”;
- (b) by substitution for entry (d) in relation to the Tawana Land Board the following new entry —
“(d) six members appointed by the Minister.”;
- (c) by substituting for entry (d) in relation to the Kgatleng Land Board the following new entry —
“(d) four members appointed by the Minister.”;
- (d) by substituting for entry (d) in relation to the Kweneng Land Board the following new entry —
“(d) six members appointed by the Minister.”;
- (e) by substituting for entry (d) in relation to the Ngwaketse Land Board the following new entry —
“(d) six members appointed by the Minister.”;
- (f) by substituting for entry (d) in relation to the Maletse Land Board the following new entry —
“(d) four members appointed by the Minister.”;
- (g) by substituting for entry (d) in the Tlokweng Land Board the following new entry —
“(d) four members appointed by the Minister.”;
- (h) by substituting for entry (d) in relation to the Barolong Land Board the following new entry —
“(d) four members appointed by the Minister.”;
- (i) by substituting for entry (c) in relation to the Tati Land Board the following new entry —
“(c) five members appointed by the Minister, one of whom shall be a sub-chief in the area.”;
- (j) by substituting for entry (c) in relation to the Chobe Land Board the following new entry —
“(c) five members appointed by the Minister, one of whom shall be a sub-chief in the area.”;

- (k) by substituting for entry (c) in relation to the Kgalagadi Land Board the following new entry –
“(c) six members appointed by the Minister, one of whom shall be a sub-chief in the area.”;
- (l) by substituting for entry (c) in relation to the Ghanzi Land Board the following new entry –
“(c) six members appointed by the Minister, one of whom shall be a sub-chief in the area.”.
