IN EXERCISE of the powers conferred on the Minister of Home Affairs by section 21 of the Citizenship of Botswana (Supplementary Provisions) Act, the following Order is hereby made —

1. This order may be cited as the Citizenship of Botswana (Supplementary Provisions) (Extension of Period for Renunciation of Citizenship) Order, 1982. Citation

2. The period in which the person named in the first column of the Schedule may make a renunciation of citizenship, take oath and make a declaration for the purposes of section 28 of the Constitution is extended to the date specified opposite thereto in the second column of the said Schedule.
