SCHEDULE

IN EXERCISE of the powers conferred on the Minister of Home Affairs by section 2 of the Employment of Non-Citizens Act, 1981, the following Order is hereby made

1. This Order may be cited as the Non-Citizens (Declaration of Citation Persons not being Non-Citizens) Order, 1983.
2. The persons listed in the Schedule hereto are hereby declared not to be non-citizens for the purposes of the Act. Declaration of person not being non-citizens
3. This Order shall not apply to a spouse or a dependant of any person specified in the Schedule hereto. Non-application of this Order
4. The Non-Citizens (Declaration of no Non-Citizens) Order, 1982, is hereby revoked. Revocation of S.I. 70 of 1982

SCHEDULE

1. Members of the Diplomatic Service who are recruited from their countries for service in the Botswana Mission.
2. Public Service employees.
3. Persons recruited abroad for service in the Public Service of Botswana.
4. Non-resident employees of the National Railways of Zimbabwe.
5. Non-resident aircraft pilots of foreign airlines and air charters.
6. Non-resident airhostesses of foreign airlines.
7. Non-resident consultants and supervising engineers on works and projects in Botswana.
8. Persons recruited abroad for service under a voluntary service programme.
9. Persons recruited abroad for service in Botswana by the United Nations (U.N.) or its agencies.
10. Teachers employed by the Unified Teaching Service.
11. Persons recruited abroad for service in Botswana by:
 - (a) Canadian International Development Agency.
 - (b) United States Agency for International Development.
 - (c) Swedish International Development Agency.
 - (d) Norwegian Agency for International Development.
 - (e) Danish International Development Agency.

- (f) Special Commonwealth African Assistance Programme.
- (g) National 4 - H Club Foundation.
- 12. Persons recruited by Williams College under the economic consultancy project.
- 13. All non-resident directors of companies registered or incorporated in Botswana.
- 14. Persons recruited abroad for service in Botswana by the United Nations High Commission for Namibia.
