| Citation | 1. These Regulations may be cited as the Registration of Societies (Amendment) Regulations, 1983. |
| Amendment of regulation 2 of Cap. 18:01 (Sub. Leg.) | 2. Regulation 2 of the Registration of Societies Regulations (hereinafter referred to as "the principal Regulations") is amended in the definition of "Register" by substituting for the words "section 6 (5)", which appear therein, words "section 9 (1) of the Act". |
| Amendment of regulation 4 of principal Regulations | 3. Regulation 4 of the principal Regulations is amended by substituting for the words "Form B", which appear therein, the words "Form B1". |
| Amendment of regulation 5 of principal Regulations | 4. Regulation 5 of the principal Regulations is amended by substituting for the words "Form C", which appear therein, the words "Form C1". |
| Amendment of regulation 8 of principal Regulations | 5. Regulation 8 of the principal Regulations is amended by substituting for the words "section 6 (6)", which appear therein, the words "section 10 of the Act". |
| Substituting of new regulation of principal Regulations | 6. The principal Regulations are amended by substituting for regulation 9 thereof the following new regulation — |
| "Cancellation of registration" | 9. (1) Where in terms of section 11 (2) of the Act the Registrar is of the opinion that the registration of a society should be cancelled, he shall notify his opinion to the society in the form set out in Form E1.
(2) Where in terms of section 11 (3) of the Act the Registrar decides to cancel the registration of a society, he shall notify his decision to the society in the form set out in Form E2.
(3) Where in terms of section 11 (5) of the Act the Registrar cancels the registration of society, he shall notify the cancellation to the society in the form set out in Form E3." |

7. Regulation 10 of the principal Regulations is amended by substituting for the words "section 7 or 8", which appear therein, the words "section 12 or 13 of the Act".

Amendment of regulation 10 of principal Regulations

8. Regulation 16 of the principal Regulations is amended by substituting for subregulations (2) and (3) thereof the following new subregulations—

Amendment of regulation 16 of principal Regulations

"(2) Where the name of a registered society is changed, the Registrar shall, on the surrender to him of the society's current certificate of registration, issue to the society a fresh certificate of registration in the form set out in Form B2.

(3) Where the name of an exempted society is changed, the Registrar shall, on the surrender to him of the society's current certificate of exemption from registration, issue to the society a fresh certificate of exemption from registration in the form set out in Form C2.

(4) A certificate issued to a society in terms of this regulation shall be deemed, for the purposes of the Act, to be a certificate of registration or of exemption from registration, as the case may be, issued under section 6 (4) of the Act.

(5) The Registrar shall also make such other amendments to the particulars concerning a society entered in the register as may be necessitated by information provided in terms of section 16 and 17 of the Act or of regulation 7."

- (a) in Form B, therein set out, by substituting for the words "FORM B", which appear therein, the words "FORM B1" and deleting the words "section 6 (1) of", which also appear therein;
- (b) by inserting therein, immediately before Form C, therein set out, the following new form —

2. By virtue of section 10 (1) of the Societies Act, you have 21 days immediately after receipt of this notification within which to apply for registration should you wish to do so.”;
