

The Minister of Finance and Development Planning may issue a warrant for the payment from the Consolidated Fund for the year ending 31st March, 1987, of the sum of P 1 067 761 300 (one thousand and sixty seven million seven hundred and sixty one thousand three hundred pula).</p> | Expenditure from Consolidated Fund |
| <p>3. The sum authorised by section 2 is appropriated to and shall be applied for purposes of the Heads of Expenditure set out in the first and second columns of the Schedule, in the amounts set out in the corresponding entries in the third column of the said Schedule.</p> | Appropriation of sum authorised by section 2 |
| <p>4. The Minister of Finance and Development Planning may issue a warrant for the payment from the Development Fund for the year ending 31st March, 1987, of the sum of P 349 688 000 (three hundred and forty nine million six hundred and eighty eight thousand pula).</p> | Expenditure from Development Fund |
