**AMENDMENT OF SCHEDULES (NO. 38) NOTICE, 1986**  
(Published on 17th October, 1986)

IN EXERCISE of the powers conferred on the Minister of Finance and Development Planning by sections 50 and 51 of the Customs and Excise Duty Act, the Schedules to the Act are amended to the extent set out in the Schedule below.

- (b) the rates of duty on expanded metal, of nickel, and pressings, stampings and other rough shapes of beer mugs, cups or similar trophies, of nickel, are increased from 10% and 15% respectively, to 20%, and
