2. Amendment of regulation 2 of the Control of Goods (Trading Margins) Regulations (Cap. 43:07 (Sub. Leg.))

IN EXERCISE of the powers conferred on the Minister of Commerce and Industry by section 3 of the Control of Goods, Prices and Other Charges Act, the following Regulations are hereby made —

Citation           1. These Regulations may be cited as the Control of Goods (Trading Margins) (Amendment) Regulations, 1987.

Amend-           2. Regulation 2 of the Control of Goods (Trading Margins) Regulations is hereby amended by the substitution for the definition of regulation 2 of the Control of Goods (Trading Margins) Regulations the term "cost price" of the following new definition —

of Goods  
(Trading Margins) Regulations  
(Cap. 43:07 (Sub. Leg.))

"cost price" of any goods in respect of a trader, means the price paid or to be paid by him for those goods excluding any discounts not exceeding ten per cent *in toto* allowable for prompt payment, bulk order or otherwise, and excluding insurance, freight and delivery charges; and where the price is stated in foreign currency the price in pula shall be ascertained by reference to the rate of exchange on the day on which the goods were imported into Botswana."
