REGULATION

IN EXERCISE of the powers conferred on the Minister of Commerce and Industry by section 3 of the Control of Goods, Prices and Other Charges Act, the following Regulations are hereby made —

1. These Regulations may be cited as the Control of Goods, Prices and Other Charges (Petroleum Prices) (Amendment) (No. 2) Regulations, 1987.

Citation

2. The Schedule to the Control of Goods, Prices and Other Charges (Petroleum Prices) Regulations, 1987 is hereby amended by the substitution for that Schedule the following new Schedule —

3. No person shall sell by retail, either in person or through an agent or employee, —

- (a) at any place specified in the first column of the Schedule, the petroleum products specified at the head of the second, third or fourth column of the said Schedule at a price exceeding the amount per litre specified in relation to that place in that column which amount includes —
 - (i) in respect of the petrol levies of two thebe per litre payable in respect of the National Petroleum Fund and the Motor Vehicle Insurance Fund respectively and levy of three thebe per litre payable in respect of the Equalization Fund,
 - (ii) in respect of diesel a levy of three thebe per litre payable in respect of the Equalization Fund,
 - (iii) in respect of diesel levies of five thebe and two thebe per litre payable in respect of the National Petroleum Fund and Motor Vehicle Insurance Fund respectively;
- (b) at any place specified in the first column of the said Schedule, illuminating paraffin for domestic use in quantities of a litre or less at a price proportionate to that specified in relation to that place in the third column of the said Schedule; or
- (c) at any place not specified in the first column of the Schedule, the petroleum product specified at the head of the —
 - (i) second column of the Schedule at a price exceeding by more than 6 thebe,
 - (ii) third column of the Schedule at a price exceeding by more than 6 thebe,
 - (iii) fourth column of the Schedule at a price exceeding by more than 6 thebe per litre the price at which the product was delivered to him.
