

An Act to amend the National Assembly (Salaries and Allowances) Act, 1988.

Date of Assent: 24th May, 1989.

Date of Commencement: 2nd June, 1989.

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the National Assembly (Salaries and Allowances) (Amendment) Act, 1989, and shall come into operation or be deemed to have come into operation on 1st April, 1989.
