

**An Act to amend the National Assembly (Salaries and Allowances) Act, 1988.**

*Date of Assent:* 20th April, 1990.

*Date of Commencement:* 1st April, 1990.

**ENACTED** by the Parliament of Botswana.

1. This Act may be cited as the National Assembly (Salaries and Allowances) (Amendment) Act, 1990, and shall come into operation or be deemed to have come into operation on 1st April, 1990.

Short title and commencement

2. (1) Paragraph 1 (1) of the Schedule to the National Assembly (Salaries and Allowances) Act, 1988 (hereinafter referred to as the principal Act) is amended —
