## ARRANGEMENT OF SECTIONS

### SCHEDULE

**An Act to authorize the payment out of the Consolidated Fund and the Development Fund of sums of money for the year ending 31st March, 1994.**

*Date of Assent:* 31.3.93.

*Date of Commencement:* 1.4.93.

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the Appropriation (1993/1994) Act, 1993.
2. The Minister of Finance and Development Planning may issue a warrant for the payment from the Consolidated Fund for the year ending 31st March 1994, of the sum of P3 843 901 740 (three thousand eight hundred and forty three million, nine hundred and one thousand, seven hundred and forty Pula).
3. The sum authorized by section 2 is appropriated to, and shall be applied for purposes of, the Heads of Expenditure set out in the first and second columns of the Schedule, in the amounts set out in the corresponding entries in the third column of the Schedule.

4. The Minister of Finance and Development Planning may issue a warrant for the payment from the Development Fund for the year ending 31st March, 1994, of the sum of P1 500 236 000 (One thousand five hundred million, two hundred and thirty six thousand Pula).

5. The sum authorized by section 4 is appropriated, and shall be applied, to meet the total amount of expenditure necessary for development projects during the financial year ending 31st March, 1994.
