The Minister of Finance and Development Planning may issue a warrant for the payment from the Consolidated Fund for the year ending 31st March, 1995, of the sum of P4 617 961 830 (four thousand six hundred and seventeen million, nine hundred and sixty one thousand, eight hundred and thirty pula). | Expenditure from Consolidated Fund |
| 3. The sum authorized by section 2 is appropriated to and shall be applied for purposes of the Heads of Expenditure set out in the first and second columns of the Schedule, in the amounts set out in the corresponding entries in the third column of the said Schedule. | Appropriation of sum authorized by section 2 |
| 4. The Minister of Finance and Development Planning may issue a warrant for the payment from the Development Fund for the year ending 31st March, 1995, of the sum of P1 590 644 000 (one thousand five hundred and ninety million, six hundred and forty four thousand pula). | Expenditure from Development Fund |
| 5. The sum authorized by section 4 is appropriated and shall be applied to meet the total amount of expenditure necessary for development projects during the financial year ending 31st March, 1995. | Appropriation of sum authorized by section 4 |
