### SCHEDULE

### **An Act to authorise the payment out of the Consolidated Fund and the Development Fund of sums of money for the year ending 31st March, 2001**

*Date of Assent:* 30.3.2000.

*Date of Commencement:* 1.4.2000.

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the Appropriation (2000/2001) Act, 2000.

2. The Minister of Finance and Development Planning may issue a warrant for the payment from the Consolidated Fund for the year ending 31st March, 2001 of the sum of P11 385 716 730 (eleven thousand three hundred and eighty five million, seven hundred and sixteen thousand, seven hundred and thirty Pula).

3. The sum authorised by section 2 is appropriated to, and shall be applied for, the purposes of the Heads of Expenditure set out in the first and second columns of the Schedule, in the amounts set out in the corresponding entries in the third column of the said Schedule.

4. The Minister of Finance and Development Planning may issue a warrant for the payment from the Development Fund for the year ending 31st March, 2001 of the sum of P3 434 468 000 (three thousand four hundred and thirty four million, four hundred and sixty eight thousand Pula).

5. The sum authorised by section 4 is appropriated to, and shall be applied to meet, the total amount of expenditure necessary for development projects during the financial year ending 31st March, 2001.
