An Act to amend the National Assembly (Salaries and Allowances) Act, 1992.

Date of Assent: 3rd September, 2001.

Date of Commencement: 1st April, 2001.

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the National Assembly (Salaries and Allowances) (Amendment) (No.2) Act, 2001, and shall be deemed to have come into operation on 1st April, 2001.

Short title and commencement

2. The National Assembly (Salaries and Allowances) Act is hereby amended in section 4 by renumbering section 4 as subsection (1) of section 4 and by the insertion therein of the following new subsection —

Amendment of section 4 of Act No. 3 of 1992

“(2) The Speaker, Deputy Speaker and each Member shall be deemed to have had incorporated into their basic salary, prescribed in the Schedule and payable over the Session of Parliament whose life commenced on the 16th October, 1999, a car subsidy allowance amounting to P120,000.”

3. The Schedule to the National Assembly (Salaries and Allowances) Act is amended —

 - (i) in subparagraph (a) by substituting for the amount P59,644.00 the amount P74,555.00;
 - (ii) in subparagraph (b) by substituting for the amount P52,392.00 the amount P65,490.00;
 - (iii) subparagraph (c) by —
 - (A) inserting the constituency “Lobatse” immediately after the constituency “Gaborone Central”; and
 - (B) substituting for the amount P46,836.00 the amount P58,545.00;
 - (iv) by substituting for subparagraph (d) the following new subparagraph —
 - “(d) for a Specially Elected Member and the Speaker of the National Assembly, at the rate of P53,460.00.”
- (d) in paragraph 5 by substituting for the amount P44.00 the amount P52.80;
- (e) in paragraph 6 by substituting in —
 - (i) subparagraph (1) for the amount P4,248.00 the amount P5,100.00; and
 - (ii) subparagraph (2) for the amount P159.20 the amount P191.05;
- (f) in paragraph 7 by substituting in —
 - (i) subparagraph (1) for the amount P16,068.00 the amount P19,284.00; and
 - (ii) subparagraph (2) for the amount P12,144.00 the amount P14,568.00.
- (g) in paragraph 8 by substituting for the amount P28.50 the amount P40.00;
- (h) by the repeal of paragraph 11;
- (i) in paragraph 12 by substituting for the amount P3,612.00 the amount P22,575.00.
