IN EXERCISE of the powers conferred on him by section 24 of the Matimela Act, the Minister of Local Government after consultation with the appropriate district councils, hereby makes the following Regulations —

Citation **1.** These Regulations may be cited as the Matimela (Amendment) Regulations, 2004.

Amendment of regulation 2 of Cap.36:06 (Sub. Leg) **2.** Regulation 2 of the Regulations (hereinafter referred to as “the Regulations”) is amended by substituting, for the words “50t” which appear therein, the words “P10”, and for the words “10t” the words “P3”.

Amendment of regulation 5 of the Regulations **3.** Regulation 5 of the Regulations is amended by substituting for the words “P50” which appear therein, the words “P500”, and for the word “three” the word “six”.

Amendment of regulation 6 of the Regulations **4.** Regulation 6 of the Regulations is amended by substituting for that regulation, the following new regulation —

“6. (1) The owner of an animal placed in a matimela kraal may claim such animal on the production of his identity card and brand certificate or upon presentation of other proof.

(2) If upon proof of ownership of a matimela by the person who claims to be the owner of a matimela, a matimela officer is satisfied that such person is the owner of a matimela, he shall release the matimela to that person.”.

Amendment of regulation 7 of the Regulations **5.** Regulation 7 of the Regulations is amended in subregulation (1) by substituting for the table which appears therein the following new table —

6. The Regulations are amended by inserting, immediately after regulation 9 thereof, the following new regulation —

10. (1) The matimela officer shall allow the matimela under his custody time to graze between 7.30 a. m and 5.00 p. m.

(2) The matimela officer shall ensure that the matimela receive, on a regular basis, such veterinary services as he may consider necessary.”.
