ARRANGEMENT OF REGULATIONS

REGULATION

1. Citation
2. Amendment of the Fourth Schedule to Cap. 69:03 (Sub. Leg.)

IN EXERCISE of the powers conferred on the Minister of Works and Transport by section 28 of the Road Transport (Permits) Act, the following Regulations are hereby made —

Citation 1. These Regulations may be cited as the Road Transport (Permits) (Amendment) (No. 2) Regulations, 2004.

Amendment of the Fourth Schedule to Cap. 69:03 (Sub. Leg.) 2. The Road Transport (Permits) Regulations, 2004 are amended —

- (a) in paragraphs 4 and 5 of the Fourth Schedule by —
 - (i) inserting the words “(Including cars, vans, mini buses up to 15 seats)” immediately after the words “less than 3500”,
 - (ii) inserting the words “(Including midi buses 16 to 30 seats)” immediately after the words “ 6501 - 8500”,
 - (iii) inserting the words “(Including buses 31 - 65 seats)” immediately after the words “14501 - 16500”, and
 - (iv) inserting the words “Including buses above- 65 seats)” immediately after the words “24501 - 26500”;
- (b) in paragraph 7 of the Fourth Schedule, by inserting immediately after the words “CROSS BORDER PASSENGER OPERATION” the following “(Applicable to all SACU countries other than Botswana)”;
- (c) in paragraph 8 of the Fourth Schedule by —
 - (i) substituting for the word “Annual” which appears in the third column, the word “Quarterly”,
 - (ii) inserting the word “above” immediately before the words “30 passengers” appearing in the fourth line of the first column;
- (d) in paragraphs 10 and 11 of the Fourth Schedule by —
 - (i) deleting the words “Goods Vehicles” which appear therein,
 - (ii) inserting the words “(Including cars, vans, mini buses up to 15 seats)” immediately after the words “less than 3500”,

- (iii) inserting the words “ (Including midi buses 16 - 30 seats)” immediately after the words “6501 - 8500”,
 - (iv) inserting the words “ (Including buses above 30 seats)” immediately after the words “14501 - 16500”;and
- (e) in paragraph 17 of the Fourth Schedule by —
- (i) by substituting the word “covers” which appear therein, with the word “covering”, and
 - (ii) inserting the words “ selling or disposing of a PSV without authorisation” immediately before the word “overloading”.
