IN EXERCISE of the powers conferred on the President by section 4 of the Local Government (District Councils) Act, the following Order is hereby made —

1. This Order may be cited as the Establishment of the Chobe District Council Order, 2006. Citation
2. (1) There shall be a district council, to be known as the Chobe District Council, in respect of the area specified in the First Schedule. Constitution and establishment of the Chobe District Council
(2) The Chobe District Council shall consist of —
(a) 7 elected members;
(b) 1 nominated member.
(c) the House of Chiefs' representative of the Chobe District.
(3) The elected members of the Chobe District Council shall be elected in the manner provided by the Electoral Act, each polling district within the Council area returning one member. Cap. 02:09
(4) The nominated member of the Chobe District Council shall be appointed by the Minister under his hand.
(5) For the purposes of this Order "polling district" means a polling district established under the Electoral Act. Cap. 02:09
3. No person shall be deemed to possess the disqualification for membership of the Council referred to in section 7 of the Act merely because he has applied for and been granted a passport issued by or under the authority of the Government of any of the countries specified in the Second Schedule. Persons not disqualified for membership of Council
4. If the seat of a member of the Council becomes vacant by virtue of any of the provisions of the Act the vacancy thus caused shall be filled in the case of — Filling of vacancies
(a) a seat occupied by an elected member, as in paragraph 2 (3) of this Order; or
(b) a seat occupied by a nominated member, as in paragraph 2 (4) of this Order.
5. The Council shall perform the functions set out in paragraph 1 of the Schedule to the Act and may perform any or all of the remaining functions set out in the said Schedule to that Act. Functions to be performed by the Council

FIRST SCHEDULE

(paragraph 2 (1))

Cap. 03:02 The area of the Chobe District Council shall be Chobe District as defined under the Administrative Districts Act.
