ARRANGEMENT OF PARAGRAPHS

IN EXERCISE of the powers conferred on the Minister of Finance and Development Planning by section 25 of the Finance and Audit Act, the following Order is hereby made —

1. This Order may be cited as the Levy on Alcoholic Beverages Fund (Amendment) Order, 2010. Citation
2. The Levy on Alcoholic Beverages Fund Order, 2008 is amended in paragraph 2 — Amendment of paragraph 2 to Cap. 54:01 (Sub. Leg.)
 - (a) by substituting for the definition of the word “Accounting Officer” the following new definition —
“Accounting Officer” means the Permanent Secretary in the Ministry of Health appointed as such under paragraph 5”;
 - (b) by substituting for the definition of the term “Department” the following new definition —
“Department” means the Department of Public Health within the Ministry of Health”.
3. The Order is amended in paragraph 5 by substituting for the words “Permanent Secretary in the Ministry of Trade and Industry” the words “Permanent Secretary in the Ministry of Health”. Amendment of paragraph 5 of the Order
4. The Order is amended by substituting for paragraph 6 the following new paragraph — Amendment of paragraph 6 of the Order
 - “6. (1) There shall be an Alcohol Levy Implementation Committee appointed by the Accounting Officer as provided under subparagraph (2).
 - (2) The Accounting Officer shall appoint the following members to the Alcohol Levy Implementation Committee —
 - (a) the Director of the Department as chairperson;
 - (b) a member from the Ministry of Trade and Industry;
 - (c) a member from the Ministry of Youth, Sport and Culture;
 - (d) a member from Botswana Confederation of Commerce Industry and Manpower (BOCCIM);
 - (e) a member from Botswana Council of Non-Governmental Organizations (BOCONGO); and
 - (f) five other members from the private and public sectors who hold the qualification or have experience that the Accounting Officer considers appropriate and relevant for the carrying out of the purposes of the Fund.

(3) The members of the Committee referred to in subparagraph (2) (d), (e) and (f) shall be appointed for a period not exceeding three years.

(4) The members of the Committee shall elect a deputy chairperson from among their number.

(5) The Committee shall be responsible for overseeing the administration and management of the Fund and for advising the Accounting Officer with respect to the Fund.

(6) The Committee shall determine its own procedures.”.
