REGULATION

IN EXERCISE of the powers conferred on the Minister of Trade and Industry by section 21 of the Registration of Business Names Act, the following Regulations are hereby made —

Citation                   **1.** These Regulations may be cited as the Registration of Business Names (Amendment) Regulations, 2010.

Amendment of regulation 8 of Cap. 42:05 (Sub. Leg.)                   **2.** Regulation 8 of the Registration of Business Names Regulations (hereinafter referred to as “the Regulations”) is amended —

- (a) by substituting for paragraph (a), the following new paragraph —  
“*(a)* on enquiry whether a proposed name may be registered..... 20”;
- (b) by substituting for paragraph (b), the following new paragraph —  
“*(b)* on lodging a statement of particulars including the issue of a certificate of registration.....150”;
- (c) by substituting for paragraph (c), the following new paragraph —  
“*(c)* on lodging a notice of change .....50”; and
- (d) by substituting for paragraph (e), the following new paragraph —  
“*(e)* on lodging a notice of cessation..... 50”.
