1. Short title and commencement
2. Amendment of Schedule to Cap. 02:06

**An Act to amend the National Assembly (Salaries and Allowances) Act.**

*Date of Assent: 25/09/2012*

*Date of Commencement: 1st April, 2012*

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the National Assembly (Salaries and Allowances) (Amendment) Act, 2012, and shall be deemed to have come into operation on 1st April, 2012.

Short title and commencement

2. The Schedule to the National Assembly (Salaries and Allowances) Act is amended by substituting for paragraphs 1 and 4, the following new paragraphs —

Amendment of Schedule to Cap. 02:06

“Salary

1. Every Member shall receive a salary which shall, except in the case of the Government Whip, the Opposition Whip and any other Member, include the responsibility allowance, calculated, in the case of —

- (a) the President, at the rate of P484,296 per annum;
- (b) the Vice President, at the rate of P372,552 per annum;
- (c) a Minister, other than an Assistant Minister, at the rate of P298,056 per annum;
- (d) the Speaker, at the rate of P298,056 per annum;
- (e) an Assistant Minister, at the rate of P248,352 per annum;
- (f) the Deputy Speaker, at the rate of P248,352 per annum;
- (g) the Leader of the Opposition, at the rate of P248,352 per annum;

- (h) the Government Whip, at the rate of P206,988 per annum;
- (i) the Opposition Whip, at the rate of P200,772 per annum; and
- (j) any other Member, at the rate of P188,160 per annum.

4. Every Member shall receive an allowance calculated as follows —

(a) for a Member representing one of the following constituencies —
