| <p>1. These Regulations may be cited as the Immigration (Amendment) Regulations, 2012.</p> <p>2. Regulation 3 of the Immigration Regulations, referred to in these Regulations as “the Regulations”, is amended by substituting for paragraph (a) (ii), the following new paragraph —</p> <p style="padding-left: 40px;">“(ii) a personal declaration to establish nationality in Form 2 set out in the Schedule or any such form as may be required by the immigration officer; or”.</p> <p>3. Regulation 9 of the Regulations is amended by substituting for the words “Form 5” which appear in the regulation, the words “Form 4”.</p> <p>4. Regulation 12 of the Regulations is amended by substituting for the regulation, the following new regulation —</p> <p>“Application for certificate of exemption</p> <p style="padding-left: 40px;">12. (1) A non-citizen may apply for a certificate of exemption in terms of section 32 of the Act in Form 3A set out in the Schedule to these Regulations.</p> <p style="padding-left: 40px;">(2) An application made under subregulation (1) shall be accompanied by a non-refundable fee of P3 000.</p> <p style="padding-left: 40px;">(3) The Director or Commissioner shall, if satisfied with the application made under subregulation (1), issue an applicant with a certificate of exemption in Form 8 set out in the Schedule.”.</p> <p>5.
