2. Amendment of Schedule to Cap. 02:06

**An Act to amend the National Assembly (Salaries and Allowances) Act.**

*Date of Assent:* 10.04.15

*Date of Commencement:* 01.04.2015

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the National Assembly (Salaries and Allowances) (Amendment) Act, 2015, and shall be deemed to have come into operation on 1st April, 2015.

Short title and commencement

2. The Schedule to the National Assembly (Salaries and Allowances) Act is amended --

Amendment of Schedule to Cap. 02:06

(a) by substituting for paragraph 1, the following new paragraph --

“Salary

1. Every Member shall receive a salary which shall, except in the case of the Government Whip, the Opposition Whip and any other Member, include the responsibility allowance, calculated, in the case of --

- (a) the President, at the rate of P651,348 per annum;
- (b) the Vice President, at the rate of P501,216 per annum;
- (c) a Minister, other than an Assistant Minister, at the rate of P439,656 per annum;
- (d) the Speaker, at the rate of P439,656 per annum;
- (e) an Assistant Minister, at the rate of P370,692 per annum;
- (f) the Deputy Speaker, at the rate of P370,692 per annum;
- (g) the Leader of the Opposition, at the rate of P370,692 per annum;
- (h) the Government Whip, at the rate of P294,180 per annum;
- (i) the Opposition Whip, at the rate of P282,756 per annum; and
- (j) any other Member, at the rate of P266,460 per annum.”;

- (b) in paragraph 2, by substituting for the words “P320.65”, the words “P339.90”;
- (c) in paragraph 4, by substituting for the words —
  - (i) “P91, 105.56” appearing in sub paragraph (a), the words “P96, 571.89”,
  - (ii) “P86, 557.08” appearing in sub paragraph (b), the words “P91, 750.50”,
  - (iii) “P82, 231.08” appearing in sub paragraph (c), the words “P87, 164.94”, and
  - (iv) “P74, 221.80” appearing in sub paragraph (d), the words “P78, 675.11”;
- (d) in paragraph 5, by substituting for the words “P74.75”, the words “P79.24”;
- (e) in paragraph 6, by substituting for the words —
  - (i) “P7, 152” appearing in sub paragraph (1), the words “P7, 581.12”, and
  - (ii) “P268.20” appearing in sub paragraph (2), the words “P284.29”;
- (f) in paragraph 7, by substituting for the words “P55.95”, the words “P59.31”; and
- (g) in paragraph 10, by substituting for the words “P31, 536”, the words “P33, 428.16”.
