1. Short title and commencement
2. Amendment of Schedule to Cap. 02:06

An Act to amend the National Assembly (Salaries and Allowances) Act.

Date of Assent: 28.08.2017

Date of Commencement: 01.04.2017

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the National Assembly (Salaries and Allowances) (Amendment) Act, 2017, and shall be deemed to have come into operation on 1st April, 2017.

Short title and commencement

2. The Schedule to the National Assembly (Salaries and Allowances) Act is amended by —

Amendment of Schedule to Cap. 02:06

(a) substituting for paragraph 1, the following new paragraph —

“Salary 1. Every Member shall receive a salary which shall, except in the case of the Government Whip, the Opposition Whip and any other member, include the responsibility allowance, calculated, in the case of —

- (a) the President, at the rate of P907,596.00 per annum;
- (b) the Vice President, at the rate of P796,140.00 per annum;
- (c) a Minister, other than an Assistant Minister, at the rate of P612,060.00;
- (d) the Speaker, at the of P612,060.00;
- (e) an Assistant Minister, at the rate of P470,976.00;
- (f) the Deputy Speaker, at the rate of P470,976.00;
- (g) the Leader of the Opposition, at the rate of P470,976.00;
- (h) the Government Whip, at the rate of P413,160.00;
- (i) the Opposition Whip, at the rate of P405,072.00; and
- (j) any other Member, at the rate of P397,092.00”.

- (b) substituting for the words “P339.90” appearing in paragraph 2, the words “P353.49”;
- (c) substituting for paragraph 4, the following new paragraph —
 - “4. Paragraph 4 is amended by substituting for —
 - (a) the words “P96,571.89” appearing in paragraph (a), the words “P135,200.57”;
 - (b) the words “P91,750.50” appearing in paragraph (b), the words “P128,450.70”;
 - (c) the words “P87,164.94” appearing in paragraph (c), the words “P122,030.91”; and
 - (d) the words “P78,675.11” appearing in paragraph (d), the words “P110,145.15”;
- (d) substituting for the words “P7,581.12” appearing in paragraph 6 (1), the words “P7,884.36”; and
- (e) substituting for the words “P33,428.16” appearing in paragraph 10, the words “P34,765.28”.
