**REGULATION**

1. Citation and commencement
2. Amendment of Cap. 43:08 (Sub. Leg.)

IN EXERCISE of the powers conferred on the Minister of Investment, Trade and Industry by section 3 of the Control of Goods, Prices and Other Charges Act, the following Regulations are hereby made —

1. These Regulations may be cited as the Control of Goods, Prices and Other Charges (Petroleum Prices) (Amendment) (No. 2) Regulations, 2017, and shall come into force on 1st November, 2017. Citation

2. The Control of Goods, Prices and Other Charges (Petroleum Prices) Regulations are amended by substituting for the Schedule, the following new Schedule — Amendment of Cap. 43:08 (Sub. Leg.)
