**An Act to amend the National Assembly (Salaries and Allowances) Act.**

*Date of Assent:* 28.08.19

*Date of Commencement:* 28.08.19

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the National Assembly (Salaries and Allowances) (Amendment) Act, 2019.

Short title

2. The Schedule to the Act is amended by substituting for paragraph 4, the following new paragraph —
