Citation	1. This Order may be cited as the Law Revision Order (No. 1/2018), 2019.
Authority for inclusion of pages in Laws of Botswana	2. As and from 31st December, 2017, the pages specified in the third column of the First Schedule of the enactments specified in the first and second columns of the said Schedule are authorised for inclusion in and shall form part of the Laws of Botswana.
Authority for removal of certain pages in Laws of Botswana	3. As and from 31st December, 2017, the pages specified in the third column of the Second Schedule of the enactment specified in the first and second columns of the said Schedule are authorised to be removed from the Laws of Botswana.
Effective date of Laws	4. The enactment referred to in paragraph 2 represent the respective Laws in force on 1st January, 2018.
Revocation of S.I. No. 31 of 2018	5. Law Revision Order, (No. 1/2017) 2018 is hereby revoked.
