| <p>1. This Act may be cited as the <i>Ntlo Ya Dikgosi</i> (Salaries and Allowances) (Amendment) Act, 2023.</p> | Short title |
| <p>2. The <i>Ntlo Ya Dikgosi</i> (Salaries and Allowances) Act (referred herein, as “the Act”) is amended in section 3 by substituting for the words —</p> <p>(a) “P49,233.03” appearing therein, the words “P60, 851.97; and</p> <p>(b) “P44,490.60” appearing therein, the words “P52, 610.14”.</p> | Amendment of section 3 of Cap. 02:08 |
| <p>3. Section 4 (1) of the Act is amended by substituting for the words “P37,200.24” appearing therein, the words, “P43, 989.29”.</p> | Amendment of section 4 of the Act |
| <p>4. The Schedule to the Act is amended by —</p> <p>(a) substituting for paragraph 3, the following new paragraph —</p> <p>“Acting allowance 3. Every member shall be paid the same amount that would have been paid to the substantive Chairperson, as acting allowance for every sitting of <i>Ntlo Ya Dikgosi</i> during the whole of which he or she presides in place of the Chairperson.”;</p> <p>(b) substituting for paragraph 6, the following new paragraph —</p> <p>“Hospitality allowance 6. (1) The Chairperson shall receive a hospitality allowance of P8149.70 per annum.</p> <p>(2) The Vice-Chairperson shall receive a hospitality allowance of P4977.33 per annum.</p> | Amendment of Schedule to the Act |

(3) The Members shall receive a hospitality allowance of P2335.03 per annum.

(4) The allowances paid under this paragraph shall be in addition to any hospitality allowances to which the Chairperson or Members may be entitled by virtue of paragraph 5.”; and

(c) by substituting for paragraph 7, the following new paragraph —
“Accommodation allowance 7. A member shall receive accommodation allowance at the rate of —

(a) P 135,000.00 per annum for the Chairperson;

(b) P64,800.00 per annum for the Vice-Chairperson; and

(c) P64,800.00 per annum for any other member.”.
